RCAL Heads to Albany for NYAIL Budget Advocacy Day 2026

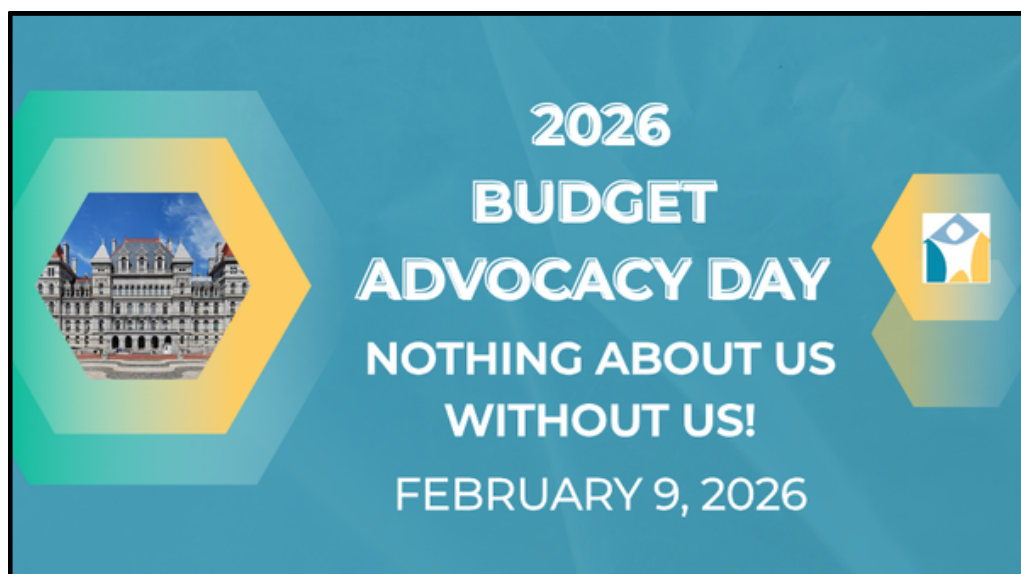

RCAL Benefits Advisement: Support You Can Count On

RCAL's Benefits Advisement program is here to help individuals and families better understand and navigate public benefits. Whether you're applying for benefits for the first time, experiencing a change in income or employment, or just have questions about how different programs work together, our Benefits Advisor can help.

RCAL provides one-on-one, confidential assistance with programs such as SSI, SSDI, Medicaid, Medicare, SNAP, and other public benefits, with a focus on helping people make informed choices that support independence and financial stability.

In addition to appointments at RCAL, our Benefits Advisement program hits the road twice each month to bring support directly into the community:

- First Wednesday of each month at the Trudy Farber Center, 50 Center St., Ellenville
- Third Wednesday of each month at the Broadway Bubble, Kingston

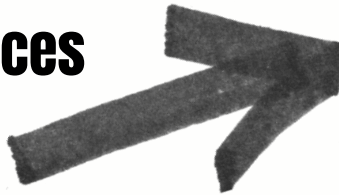

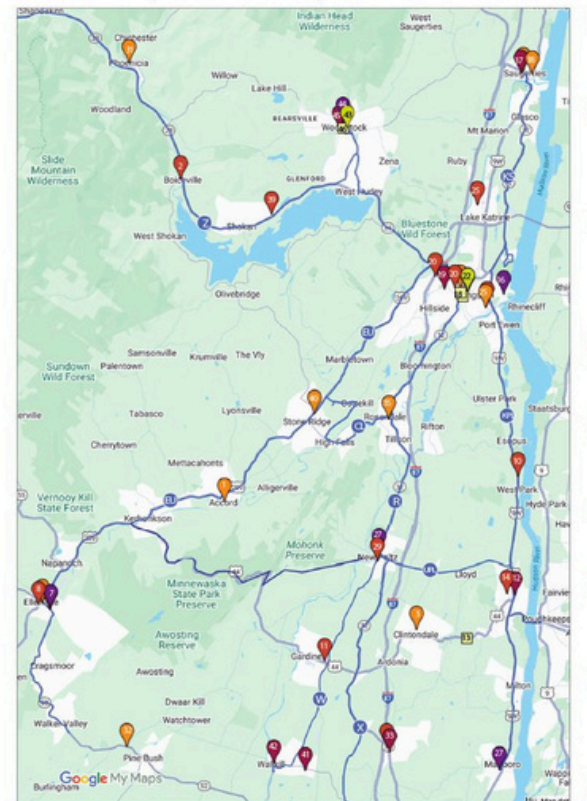
Accessing Food Resources in Ulster County

ULSTER COUNTY Food Pantries & Meal Programs accessible by Ulster County Area Transit (UCAT)



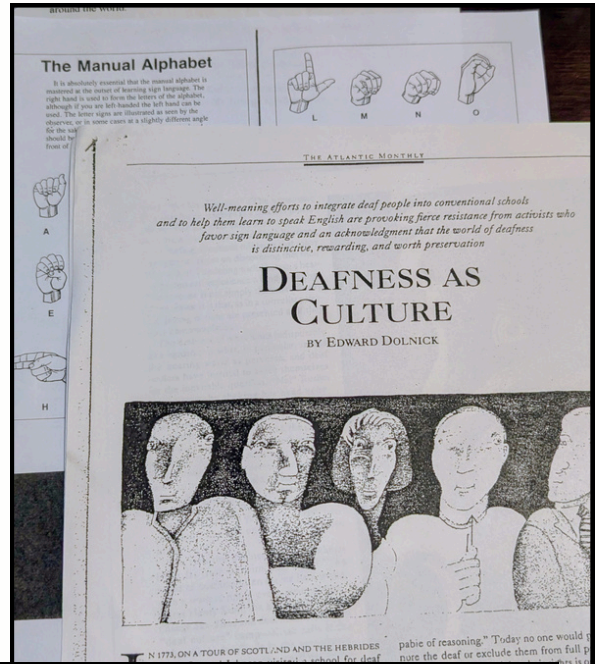
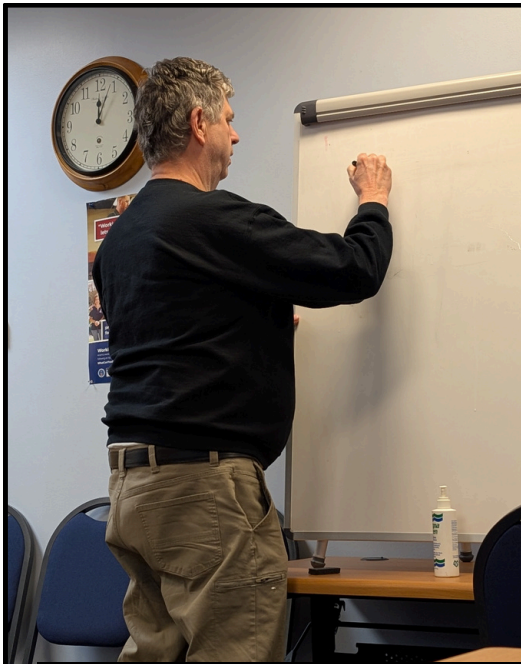

January kicked off the first lunch and learn ASL series for RCAL employees. A group of employees from all different departments spent their lunch hour increasing their communication skills, building rapport, and having fun while learning ASL from RCAL's Systems Advocate, Vernon Bonse.

The class began with a short quiz about deaf heritage before introducing the alphabet, finger spelling and some quick phrases like "hello" "how are you" and "good morning." Vernon also shared how deaf individuals still face discrimination today.
