Judy Heumann The Mother of Disability Rights

The month of July is observed as Disability Pride Month. To close out this important month, the Disability and Health Program would like to focus attention on Judy Heumann, known as the "mother" of the Americans with Disabilities Act (ADA)





Judy played a crucial role in the development and implementation of disability rights and legislation.

Judy was raised by her German-Jewish immigrant parents, who migrated to the United States in the 1930's. As Judy and her parents were fortunate enough to start a new life in America, many of Heumann's family members were murdered during the Holocaust. Judy was born on December 18th, 1947, in Philadelphia, Pennsylvania. At 18 months old, Judy contracted polio in Brooklyn, New York, which resulted in permanent paralysis. Judy was denied the right to attend school because the school was not accessible, and she was seen as a "fire hazard" in case of emergency events.

It was Judy's mother who spent nearly half a decade fighting for her daughters' rights to be able to attend school. With her efforts, Judy was able to finally attend school in the fourth grade, but under a program called Health Conservation 21. Located in the basement of the school, the program provided minimal education for individuals between the ages of 9 and 21 who had a disability. Judy and her fellow peers were segregated from other students. It was clear that the students who were not disabled were given better academic resources at a much faster pace compared to her and her classmates.

Judy and her fellow peers were segregated from other students. It was clear that the students who were not disabled were given better academic resources at a much faster pace compared to her and her classmates.

In 1969 Judy applied for her teaching license and passed her written and oral exams but was failed on her medical exam because she could not walk. So, years after her battle to attend school; Judy would confront the same Board of Education (BOE) for denying her of her teaching license. She sued the New York State BOE, and support came from Judge Constance Baker Motley, who was the first Black female federal judge. Justice Motley suggested the BOE reconsider and allow Judy to receive her teaching license. Ultimately, she was granted her teaching license making her the first wheelchair-user to become a teacher in the state of New York. In 1975 Judy received a master's in public health (MPH) from UC Berkeley School of Public Health.

Judy's early experiences fostered an interest in learning about the disability community and developing connections within her environment. As Judy began to advocate for disability rights, she credited her parents for the strong influence and encouragement they gave to fight for equality and justice. Judy has been recognized for her many outstanding achievements including her appointment as the Special Advisory on International Disability Rights at the U.S. Department of State by President Barack Obama, serving as a founding member the Berkeley Center for Independent Living (the grassroots program that helped to launch the Independent Living Movement both nationally and globally), and becoming the first Director for the Department on Disability Services in Washington D.C., where she oversaw the Developmental Disability Administration and Rehabilitation Services Administration.

As Judy became an advocate for disability rights, she became recognized as the "mother' of disability rights movement. One of Judy's most empowering experiences was her time during the 504 Sit-In in San Francisco, California. The 26-day protest was the longest sit-in at a federal building with over 100 protestors that participated. The goal of the sit-in was to have the Rehabilitation Act signed into law which would allow individuals with a disability to not be excluded from participation, denied benefits or face discrimination under any activity or program in the United States. Judy gave a speech outside of the HEW building. Her words not only made an impact for the people in the United States but throughout the whole world. She encouraged individuals to advocate for change and to speak up against injustices, just like her parents did.

"We have believed that if we played by the rules and did what we were told, we would be included in the American Dream. We have waited too long, made too many compromises, and been too patient. We will no longer be patient. There will be no more compromise. We will accept no more discrimination." – Judy Heumann

Judy served on multiple non-profit boards, such as Association of People with Disabilities, Disability Rights Education, and Human Rights Watch, among others. Her dedication and resilience inspired many others. She cofounded the World Institute on Disability (WID) with Ed Roberts and Joan Leon. She brought visibility to the disability rights movement through her authorship of books "Being Heumann" and the "Rolling Warrior," both novels that focused on Judy's experiences and fighting for disability rights.

Judy passed away at the age of 75 on March 4th, 2023, in Washington D.C. The "mother" of disability rights movement will be remembered and honored for her resilience, relentless and fierce advocacy, and unbreakable spirit. She empowered not only the disability community but inspired all who want to make a difference and fight for change.


